PULSE PRODUCTIONS INC. PRIVACY INFORMATION

Your privacy is critically important to us. At Pulse Productions Inc. we have a few fundamental principles:

- We don't ask you for personal information unless we truly need it. (We can't stand services that ask you for things like your gender or income level for no apparent reason.)
- We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of one of our services.

Pulse Productions Inc., operates several websites including pulseproinc.com and pulseent.com. It is Pulse Productions Inc. policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors

Like most website operators, Pulse Productions Inc. collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Pulse Productions Inc. purpose in collecting non-personally identifying information is to better understand how Pulse Productions Inc. visitors use its website. From time to time, Pulse Productions Inc. may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Pulse Productions Inc. also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on

our blog. Pulse Productions Inc. only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that blog commenter IP addresses are visible and disclosed to the administrators of the blog where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to Pulse Productions Inc. websites choose to interact with Pulse Productions Inc. in ways that require Pulse Productions Inc. to gather personally-identifying information. The amount and type of information that Pulse Productions Inc. gathers depends on the nature of the interaction.

Aggregated Statistics

Pulse Productions Inc. may collect statistics about the behaviour of visitors to its websites. For instance, Pulse Productions Inc. may monitor the most popular pages on the pulseproinc.com & pulseent.com site. Pulse Productions Inc. may display this information publicly or provide it to others. However, Pulse Productions Inc. does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information. Pulse Productions Inc. discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Pulse Productions Inc. behalf or to provide services available at Pulse Productions Inc. websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Pulse Productions Inc. websites, you consent to the transfer of such information to them. Pulse Productions Inc. will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Pulse Productions Inc. discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Pulse Productions Inc. believes in good faith that disclosure is reasonably necessary to protect the property or rights of Pulse Productions Inc., third parties or the public at large. If you are a user of an Pulse Productions Inc. websites and have supplied your email address, Pulse Productions Inc. may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Pulse Productions Inc. and our products & services.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Pulse Productions Inc. uses cookies to help Pulse Productions Inc. identify and track visitors, their usage of Pulse Productions Inc. websites, and their website access preferences.
